In accepting the responsibility to act in furtherance of your interests, we agree to forego potential business opportunities that might be inconsistent with your interests. Therefore, retainers are non-refundable.

If any legal action is necessary to enforce or interpret the terms of this Professional Service Agreement or if an unpaid statement for professional services is referred to an attorney for collection, the Client agrees to pay all costs of collection, including but not limited to, reasonable attorney fees, court costs and any other legal fees. This agreement shall be governed by the laws of the State of Florida and Client agrees that all legal actions to enforce or challenge this agreement, will take place in the Circuit Court of Broward County, Florida or in the Federal District Court for the Southern District of Florida, Miami Division.
